It is a highly active blend of absorbant polymers and wetting agents designed to enhance the wetting and the elimination of fine dust particles, by building the agglomerate size and retarding particle degradation. INSTRUCTIONS FOR USE:

POLYMERIC DUST CONTROL **NCMDC** is formulated for use in D & C transfer facilities and landfills. It offers advanced dust control. **NCMDC** will offer best results when injected into a spray system for application. Recommended for use at the rate of five gallons per 1,000 gallons of water. The actual use concentration is determined by the individual operation & the dispersion equipment etc.
