Odors are eliminated with a complex polymer neutralization system which effectively captures malodorous molecules and neutralizes on contact. Combined with a synthetic odor modifying fragrance, a diversity of odors are controlled. 950 NEUTRALIZER is environmentally safe and contains no hazardous materials. All components are biodegradable. It is formulated for commercial and industrial use and should not be used for household applications.

DIRECTIONS FOR USE:

950 NEUTRALIZER may be used for control of difficult odor conditions found in dumpsters, landfills, transfer stations, garbage compactors and sewage treatment. Spray dilution on to garbage or sewage on a regular basis with an automatic dispersing system. For use in odor control around landfills and waste treatment facilities, 950 NEUTRALIZER may be effectively used at a dilution of 250 to 1 for dispensing by an air atomizing system.
